

THIS IS THE LAST WILL AND TESTAMENT of me NOEL McGLASHAN SANDES of Gore in the Provincial District of Otago and Dominion of New Zealand Land Agent.

1. I REVOKE all wills and other testamentary dispositions at any time heretofore made by me.

2. IF my wife ELLA MARIAN SANDES shall survive me for one month I GIVE DEVISE AND BEQUEATH all my real and personal estate of whatsoever kind and wheresoever situate which I shall be possessed of or entitled to or over which I shall have any disposing power at the time of my decease (including the proceeds to arise from any Policy or Policies of Assurance upon my life or against death by accident or to which I shall be beneficially entitled) unto my said wife absolutely AND I APPOINT my said wife sole Executrix of this my will.

3. I DIRECT that if my wife the said Ella Marian Sandes shall predecease me or shall die within one month after the date of my death the following provisions shall be read in substitution for the prior provisions of this my will:-

(1) I GIVE DEVISE AND BEQUEATH all my real and personal estate of whatsoever kind and wheresoever situate which I shall be possessed of or entitled to or over which I shall have any disposing power at the time of my decease (including the proceeds to arise from any Policy or Policies of Assurance upon my life or against death by accident or to which I shall be beneficially entitled) unto my daughter SHIRLEY ELIZABETH WARDS absolutely AND I APPOINT my said daughter sole Executrix of this my will.

4. I DIRECT that if both my wife the said Ella Marian Sandes and my daughter the said Shirley Elizabeth Wards shall predecease me or shall die within one month after the date of my death the following provisions shall be read in substitution for the provisions of Clause 3 (1) of this my will:-

(i) I APPOINT my son-in-law WILLIAM WARDS (hereinafter referred to as "my Trustee") to be the Executor and Trustee of this my will.

(ii) I GIVE DEVISE AND BEQUEATH all real and personal property of whatsoever kind and wheresoever situate which I shall be possessed of or entitled to or over which I shall have any disposing power at the time of my death unto my Trustee to divide the same amongst all the children of my daughter the said Shirley Elizabeth Wards as tenants in common in equal shares absolutely.

(iii) I DIRECT my Trustee to retain as authorized investments in my estate all or any investments bonds debentures shares or securities held by me at the date of my death or in which I may then be interested or concerned notwithstanding the hazardous or unauthorised nature thereof AND I DECLARE that my Trustee shall not be responsible for any loss or losses occasioned by such retention AND I EMPOWER my Trustee to accept or take up any bonus shares or other rights or benefits issued or given by any Company in which my estate may be interested or concerned and to determine whether such bonus shares or other rights or benefits are capital or income notwithstanding the decision of the company in such matter.
