AND I DECLARE that my Trustee the said MORRIS JAMES MORRISSEY .... shall be entitled to charge for and shall be paid out of my Estate for .. any business (whether strictly professional or not) done in relation to my Estate or affairs by him or any firm of solicitors of which he may be a . member in like manner as he would be entitled to charge my Executors and Trustees as if employed by my Executors and Trustees to do such business as their solicitor.
